DIMS

Setting the Bond Amount

- The officer will set a reasonable bond pursuant to TCCP, Arts. 17.20 and 17.22.
- The bond will be based upon the Recommended Bond Schedule established by the El Paso County Council of Judges
- The officer may consider the defendant's criminal history, and any applicable multipliers (felony offenses) in setting a reasonable bond.

 - Only cases where attorney is the attorney of record

- **What information can a defense attorney find on the Portal?**
 - Police reports
 - Media → Photo, Videos, Audio Recordings
 - Records → Phone, Business, Judgments, Pen Packets, Lab Reports, etc.
 - Court's file
 - Hearing dates
 - Plea Recommendation
 - Defendant's local criminal history

 - Defense attorney must request access to the case
 - DA's office verifies the following information:
 - ✦ Attorney is the attorney of record
 - ✦ Case has been filed
 - ✦ Defendant has been arrested or arraigned in El Paso
