RE: Response to the Texas Indigent Defense Commission's Third Follow-up Review of Jefferson County, Texas, in June 2025.

Dear Mr. Lieurance:

Texas Indigent Defense Commission (TIDC) representatives

Ashley DeLaGarza, Cody Huffman, and Joel Lieurance conducted an
on-site visit to Jefferson County on March 25, 2025, to follow up on
recommendations made by the previous TIDC October 2022 review
report. Upon completing the 2025 review, TIDC noted that the only
remaining deficiency involved the untimely appointment of counsel for
County Court misdemeanor defendants making bail shortly after

magistration. See, TIDC's Third Follow-up Review of Jefferson County's Indigent Defense Systems, June 2025, at P. 10 [hereafter "TIDC June 2025 Report"]. The District Courts were found to be in compliance with this requirement for felony defendants.

In the District Courts, indigent defendants are immediately appointed counsel by the magistrate judge. In County Courts, appointments for indigent defendants have been made by the staff of each individual court at the defendant's initial appearance¹. As noted by the TIDC, this process violates *Rothgery v. Gillespie County*, 554 U.S. 191 (2008). *See*, TIDC June 2025 Report at P. 7.

Previously, in October 2022, this same issue was deemed to be applicable to all of the Jefferson County criminal courts by the TIDC. At that time, in its TIDC Response, the Criminal Courts pledged to ensure timely appointment by the following language:

"Concerning the new issue, TIDC identified it as follows:

Requirement 4: appoint counsel promptly.

2022 Recommendation 1: Appointments of counsel are delayed for defendants making bail in the period between Article 15.17 counsel requests and the court coordinator making appointments of counsel.

To address this issue to the satisfaction of the TIDC, the Indigent Defense Coordinator is now timely appointing counsel within one (1) working day in response to the magistrate's ruling made during the Article 15.17 hearing, irrespective of bail status. In the event of the Indigent Defense Coordinator's absence from the office, another Court Clerk in the office will be instructed to make the appointments timely."

The TIDC accepted the foregoing response in October 2022.

Unfortunately, the County Courts did not strictly adhere to this assertion.

To remedy the continuing deficiency, the County Court Judges have resolved to *strictly* monitor and ensure staff compliance with the previously articulated policy set forth above. All indigent misdemeanor defendants will now be appointed counsel within one (1) working day in accordance with the assertions previously made in the October 2022 response.

Overall, Jefferson County has made great strides in achieving the objectives of the code, administrative regulations, and the TIDC's specifically articulated issues. We enjoy a professional and collegial relationship with TIDC representatives.

2025 Third Follow-up Review of Jefferson County's Indigent Defense
Systems is a collaborative product of the County Court at Law Judges of
Jefferson County. Both County Court at Law Judges have reviewed
