Milam County Plan of Action based on findings of Texas Indigent Defense Commission, April 2018 review

Based on the finding 1 and recommendation under requirement 2, the Court will make a ruling on indigence based solely on the financial standards and if the Defendant withdraws the request prior to a ruling on the request, that withdrawal shall be noted and no ruling on indigence will be made.

Based on the finding 2 and recommendation under requirement 4, the Court will generally rule on each request promptly as it arrives instead of waiting until the date of arraignment. The Court will make every effort to rule on all requests within 3 days of receiving the request in the Court's file. At the time a request is made, a defendant is provided with a letter (see attached) that explains the County Judge will review their request with them and potentially ask additional questions regarding the defendant's financial status pursuant to the Milam County Indigent Defense Plan. If the defendant bonds out they are still expected to appear on the date provided in the letter. If the defendant does not appear on the date provided, the request remains in the court's file until arraignment as explained in the letter.

Based on the finding 3 and recommendation under requirement 4, the arraignment form letter will be amended to remove the third paragraph entirely and change the wording in paragraph 2 removing "Unless you have requested a court appointed attorney, you may contact the County Attorney's office @ (254-697-7013) to discuss your case, however, this is not required." The paragraph will be replaced with the statement "If you have not already hired an attorney by this setting, you will have the opportunity to request a court appointed attorney".
